You can download transactions from your banks directly into QuickBooks Online Plus. To get started:

- Click Set Up Connections. Follow the onscreen instructions.
- Click Set Up Connections again for each additional bank or financial institution.
- To see results, select an account's row and click All Downloaded Transactions (for just the downloaded transactions) or Register (for all transactions).

From now on, any new transactions from most banks will be automatically downloaded every day.
